1. County Judge: Receive the Funding Plan for the Preservation and Restoration of the County and District Clerk's Records Archives.

Candace Garrett, County/District Clerk recommends maintaining the Somervell County/District Clerk 2014-15 Records Management and Archive Plan. The money is being used to digitize old records. The Clerk's Office receives about \$20,000 yearly from this fee. The Records Archive fee and the Records Management and Preservation fee will revert back from \$10 to \$5 maximum on 09/01/2019. The old land records have been scanned and are in the process of being indexed. This project should be completed by the end of the year and will be available on line.
